during the last 25 years life expectancy at age 50 in the united states has been rising but at a slower pace than in many other high income countries such as japan and australia this difference is particularly notable given that the united states spends more on health care than any other nation concerned about this divergence the national institute on aging asked the national research council to examine evidence on its possible causes according to explaining divergent levels of longevity in high income countries the nation s history of heavy smoking is a major reason why lifespans in the united states fall short of those in many other high income nations evidence suggests that current obesity levels play a substantial part as well the book reports that lack of universal access to health care in the u s also has increased mortality and reduced life expectancy though this is a less significant factor for those over age 65 because of medicare access for the main causes of death at older ages cancer and cardiovascular disease available indicators do not suggest that the u s health care system is failing to prevent deaths that would be averted elsewhere in fact cancer detection and survival appear to be better in the u s than in most other high income nations and survival rates following a heart attack also are favorable explaining divergent levels of longevity in high income countries identifies many gaps in research for instance while lung cancer deaths are a reliable marker of the damage from smoking no clear cut marker exists for obesity physical inactivity social integration or other risks considered in this book moreover evaluation of these risk factors is based on observational studies which unlike

randomized controlled trials are subject to many biases

cardiac arrest can strike a seemingly healthy individual of any age race ethnicity or gender at any time in any location often without warning cardiac arrest is the third leading cause of death in the united states following cancer and heart disease four out of five cardiac arrests occur in the home and more than 90 percent of individuals with cardiac arrest die before reaching the hospital first and foremost cardiac arrest treatment is a community issue local resources and personnel must provide appropriate high quality care to save the life of a community member time between onset of arrest and provision of care is fundamental and shortening this time is one of the best ways to reduce the risk of death and disability from cardiac arrest specific actions can be implemented now to decrease this time and recent advances in science could lead to new discoveries in the causes of and treatments for cardiac arrest however specific barriers must first be addressed strategies to improve cardiac arrest survival examines the complete system of response to cardiac arrest in the united states and identifies opportunities within existing and new treatments strategies and research that promise to improve the survival and recovery of patients the recommendations of strategies to improve cardiac arrest survival provide high priority actions to advance the field as a whole this report will help citizens government agencies and private industry to improve health outcomes from sudden cardiac arrest across the united states

drawing on the work of the roundtable on evidence based medicine the 2007 iom annual meeting assessed some of the rapidly occurring changes in health care related to new diagnostic and treatment tools emerging genetic insights the developments in information technology and healthcare costs and discussed the need for a stronger focus on evidence to ensure that the promise of scientific discovery and technological innovation is efficiently captured to provide the right care for the right patient at the right time as new discoveries continue to expand the universe of medical interventions treatments and methods of care the need for a more systematic approach to evidence development and application becomes increasingly critical without better information about the effectiveness of different treatment options the resulting uncertainty can lead to the delivery of services that may be unnecessary unproven or even harmful improving the evidence base for medicine holds great potential to increase the quality and efficiency of medical care the annual meeting held on october 8 2007 brought together many of the nation s leading authorities on various aspects of the issues both challenges and opportunities to present their perspectives and engage in discussion with the iom membership
